QUALIFYING CRITERIA

At the sole discretion of Carolina Cat, a qualifying referral will be determined in accordance with the following criteria:

- Referee has not purchased a new Caterpillar Building Construction Products (BCP) or Global Construction Infrastructure (GCI) machine from Carolina Cat since January 1, 2016*.
- A new machine is defined as a reading of 50 hours or less on the hour meter.
- Qualifying machines are any model of Caterpillar Building Construction Products (BCP) or Global Construction Infrastructure (GCI).
- Used machinery or rental roll-outs do not qualify as new machine sales.
- Offer not valid for incomplete, false, illegible, or self-referring submissions. No responsibility will be taken by Carolina Cat for referral submissions that are lost, misdirected, improperly recorded, or not received for any other reason.
- Referrer cannot be employed by the purchasing (referee) company or related entity.
- By submitting a referral, you agree to abide by the Carolina Cat Customer Referral Program Terms and Conditions.

TERMS AND CONDITIONS

- Carolina Cat invoice for qualifying new machine sale must be dated on or before December 31, 2021. Upon invoice, one (1) Cat prepaid Credit will be emailed to referrer (see Payment, below).
- In the case of an identical or substantially similar referral, the referral that was received first will qualify for the \$500 prepaid card. Each lead is timestamped by the form submission entry.
- The Carolina Cat Refer a Friend Program expires at 5:00 PM EST on December 31, 2021.
- Referee must be within Carolina Cat's defined sales territory in Western North Carolina.
- Referrer must be a legal resident the United States and 18 years of age or older.
- Carolina Cat employees are not eligible to submit referrals with this program.
- Carolina Cat has the right to set a limit on the number of qualified referrals submitted by a single referrer.
- At its sole discretion, Carolina Cat reserves the right to cancel the Refer a Friend Program or to revise these Terms and Conditions at any time, without prior notice. Any changes will be posted on this web page.
- At the sole discretion of Carolina Cat, referrals may be disqualified if any Terms and Conditions of the Refer A Friend Program have been breached.
- At its sole discretion, Carolina Cat reserves the right to refuse participation in the Refer A Friend Program based on referrer's and/or referee's lack of observing the Terms and Conditions of the program.
- Referrer represents and warrants that they are eligible to participate in the program with no conflict of interest. Specifically (a) that you have disclosed your participation to your employer, if you have an obligation to do so; (b) that you have obtained all necessary approvals from your employer with respect to participating in the Refer A Friend Program and any compensation that may result; or (c) that you are under no obligation to disclose participation to any other party.
- Carolina Cat's maximum liability to you under this program is limited to the above described referral fee which may be payable to you in accordance with the rules of the Refer A Friend Program.

PAYMENT

- All federal, state, provincial, and local laws apply. A qualifying participant is solely responsible for all applicable federal, state, and local taxes.
- Cat prepaid credits may be used for the purchase of Cat parts, service, attachments, merchandise or rentals at any Cat dealer or Cat Rental Store located in North America. It is not redeemable for cash. Cat prepaid credits have an expiration date and cannot be reopened once expired.
- You do not have to have a Cat Commercial Card to redeem the Cat prepaid credit, nor do you have to apply for one.
- If you do have a Cat Commercial Card, the Cat prepaid credit is not connected and cannot be used to pay on your account.
